CIDA monitors candidate programs closely in order to aid in program development. Candidate programs are required to host at least one focused site visit to maintain candidacy status so that CIDA may monitor progress toward accreditation. The focused site visit is required in three years, in <u>fall 2025</u>, to monitor progress toward improvement in the following Standards:

Standard 1. Program Identity and Context. The interior design program provides a professional-level education that prepares graduates for entry-level practice and advanced study. The program has a mission, educational philosophy, and goals appropriate to its context. The program engages in ongoing assessment and planning ensuring the curriculum and resources are structured to achieve its goals. The public is able to access understandable and reliable information about the program.

Standard 2. The interior design program has an effective administrative structure, as well as adequate and appropriate faculty and administrative staff to successfully lead and deliver the program.

Standard 5. Interior designers collaborate and also participate in interdisciplinary teams.

Standard 10. Interior designers apply knowledge of history and theory of interiors, architecture, decorative arts, and art when solving design problems.

Standard 12. Light and Color. Interior designers apply the principles and theories of light and color effectively in relation to environmental impact and human wellbeing.

Standard 16. Interior designers apply laws, codes, standards, and guidelines that impact human experience of interior spaces.

The program coordinator will be notified of the details of this focused site visit well in advance.

Because candidacy status is granted for a non-renewable term not to exceed five years, the program must seek accreditation by $\underline{\text{fall 2027}}$ in order to maintain status with CIDA. Site visits for accreditation must be scheduled at least one year prior to the end of the five-year term of candidacy.

Published information regarding your candidacy status must comply with CIDA's confidentiality and disclosure policy as stated in CIDA's Candidacy Status policy, page 7 (enclosed for your review). It is important that all announcements of CIDA candidacy include the name of the program and the degree awarded.
