The Council for Interior Design Accreditation (CIDA) seeks to identify and celebrate innovative teaching and program-related practices that advance the cause of excellence in interior design education.

Eligibility: open to all CIDA-accredited programs

- a. full-time or part-time faculty members
- b. collaborating teams with at least one faculty member (may include students, practitioners, others)

Submission Guidelines: demonstration of innovative practice is at the discretion of the applicant(s)

- a. format: submit digitally on a flash drive or CD to the CIDA office.
- b. text only format is discouraged; video (.wmv format only please), web-based, PowerPoint formats are encouraged
- c. length of presentation: 10 minutes or less
- d. signed form permitting CIDA fair use of the submitted project

CIDA, prepared to disseminate innovative practices in interior design education, reserves the right to distribute digital copies of winning work to allied organizations and other groups for public review

Project Review

A jury selected by CIDA will review applications and identify winners

CIDA INNOVATION IN INTERIOR DESIGN AWARD
